A. Conditional Use Permit No. 474 2057 S. Atlantic Boulevard ASC Treatment Group 2057 S. Atlantic Boulevard Commerce, CA 90040

A request for a conditional use permit to allow for the establishment of a mental health clinic, in conjunction with corporate office space. The property is in the C/M-1 (Commercial/Manufacturing) Zone.

Staff recommendation: Conditional approval

B. Conditional Use Permit No. 464 3041 Vail Avenue

Sprint PCS 310 Commerce Irvine, CA 92602

A request for a conditional use permit to allow for the collocation and modification of an existing monopole antenna structure that will consist of removing three (3) existing mounted panel antennas and replacing them with three (3) new panel antennas (1 per sector), six (6) new remote radio units (RRU) (2 per sector), and replacing the existing equipment cabinet with new equipment cabinet The property is located in the M-2 (Heavy Industrial) zone.

Staff recommendation: Conditional Approval

C. Conditional Use Permit No. 472 6525 Flotilla

Sprint PCS 310 Commerce Irvine, CA 92602

A request for a conditional use permit to allow for the collocation and modification of an existing monopole (monopalm) antenna structure that will consist of removing three (3) existing mounted panel antennas and replacing them with three (3) new panel antennas (1 per sector), nine (9) new remote radio units (RRU) (3 per sector), and retrofit the existing equipment cabinet. The property is the zoned M-2 (Heavy Industrial).
