A request to deviate from the sign development regulations of the Zoning Code and allow for two directional signs to be located atop of a new ninestory parking structure. The proposed signs will require deviations from Chapter 19.25 of the Commerce Municipal Code (CMC), to allow the proposed signs to encroach into the public right of way as well as exceed the permissible sign area for a directional sign.
