A. Conditional Use Permit No. 477 & Variance No. 13-01
APN:6336-009-906
Northeast corner of the intersection of Telegraph Road and Washington Boulevard, immediately adjacent to the Costco Business Center and the Costco gasoline station.

Nadel Studio One, Inc. for Fountainhead Dev. 3050 Pullman Street Costa Mesa, CA 92626

A request for a conditional use permit to allow for the construction of a new 2,821 square foot Farmer Boys restaurant and drive-through in the City's C-2 zone and a request for a variance for a reduction in the required queuing space in the restaurant's drive-through area. The distance between the drive-through entrance and its menu board and drive-up window is less than the minimum required pursuant to the Commerce Municipal Code, this item was continued from the meeting of February 27, 2013.

Nadel Studio One, Inc. for Fountainhead Dev. 3050 Pullman Street Costa Mesa, CA 92626

A request for a conditional use permit to allow for the construction of a new 2,400 square foot restaurant and drive-through in the City's C-2 zone. Pursuant to Table 19.11.030A of the Commerce Municipal Code, approval of a conditional use permit is required for eating places with drive-through services, this item was continued from the meeting of February 27, 2013.

Staff recommendation: Conditional approval

C. Conditional Use Permit No. 480 7272 E. Gage Avenue

Sprint PCS c/o Technology Associates 9601 Irvine Center Drive Irvine, CA 92618

A request for a conditional use permit to allow for the collocation of an existing wireless telecommunications facility where the equipment is mounted behind the existing screen wall on top of the penthouse of the Ramada Inn Hotel building. The proposal includes replacing three (3) 4 feet panel antennas with three (3) 6 feet panel antennas,

three (3) new radio units (RRH's), and a small junction box to be installed inside the existing equipment shelter, in the C-2 (Commercial) Zone.
