A. Conditional Use Permit No. 460

Joe's Commerce Union 6810 E. Slauson Avenue Commerce, CA 92806

A request for a conditional use permit to allow for the establishment and operation of a Type 20 Alcoholic Beverage License for the sale of beer and wine for off-site consumption for an approved convenience store at the Joe's Commerce Union, in the M-2 (Heavy Industrial) Zone.

Staff recommendation: Conditional approval

B. Conditional Use Permit No. 463

Metro PCS California, LLC 6285 Randolph Road Commerce, CA 90040

A request for a conditional use permit to allow the collocation of antennas equipment to be mounted on an existing Southern California Edison (SCE) Transmission Tower structure at a height of 63 feet. Furthermore, the proposed mounted antennas equipment exceeds the City's height restriction of 35 feet in the PF (Public Facility) Zone and therefore the applicant is also seeking approval of a Variance.

Staff recommendation: Conditional Approval

C. Variance No. 12-01

Metro PCS California, LLC 6285 Randolph Road Commerce, CA 90040

A variance is requested to allow the collocation of antennas equipment be mounted on an existing Southern California Edison (SCE) Transmission Tower structure at a height of 63 feet, which exceeds the height restriction of 35 feet in the PF (Public Facility) Zone.

Staff recommendation: Conditional Approval
