A. Conditional Use Permit No. 483 100 Citadel Drive, Suite 222

Craig Guest 4100 MacArthur Boulevard, Suite 200 Newport Beach, CA 92660

A request for a conditional use permit to allow for on-site consumption of alcoholic beverages (Type 41, On-Sale Beer and Wine for Bona Fide Public Eating Place) at an existing Ruby's Diner restaurant in the Citadel Outlets, located in the C-2 (Unlimited Commercial) Zone.

Staff recommendation: Conditional approval

B. Conditional Use Permit No. 486 6301 S. Garfield Avenue

Eukon Group/Jerry Ambrose 3905 State Street #7-188 Santa Barbara, CA 90703

A request for a conditional use permit to allow the collocation of new panel antennas to be mounted on an existing Southern California Edison (SCE) Transmission Tower structure at a height of 51 feet. Furthermore, the proposed mounted antenna equipment exceeds the City's height restriction of 35 feet in the PF (Public Facility) Zone and therefore the applicant is also seeking approval of a variance.

Staff recommendation: Conditional approval

C. Variance No. 13-05 6301 S. Garfield Avenue

Eukon Group/Jerry Ambrose 3905 State Street #7-188 Santa Barbara, CA 90703

A request for a variance to allow the collocation of new panel antennas to be mounted on an existing Southern California Edison (SCE) Transmission Tower structure at a height of 51 feet, which exceeds the height restriction of 35 feet in the PF (Public Facility) Zone.
