Request for approval of a Variance to deviate from the minimum lot size requirements and allow the construction of a new warehouse building with mezzanine space measuring 7,423 square feet in the M-2 (Heavy Industrial) Zone. Per Chapter 19.11 of the Commerce Municipal Code (CMC), a minimum lot size of 25,000 square feet is required for all new development in the M-2 (Heavy Industrial) Zone. In this case, the applicant is requesting to deviate by 795 square feet and develop on a lot measuring approximately 24,205 square feet.
